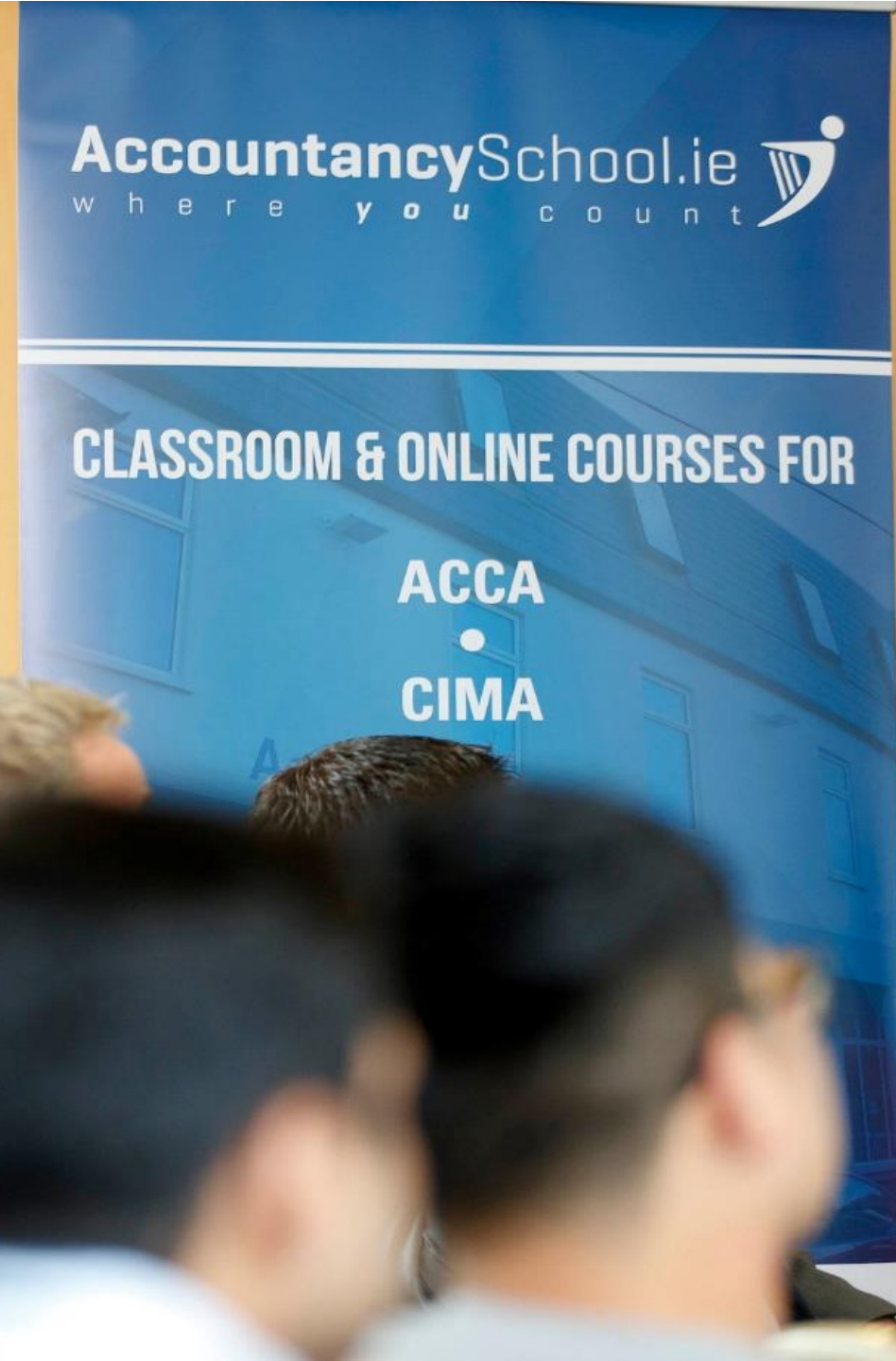

Strategic Professional (SP) Papers:



These can be sat in any order.



General rule is to attempt SBL first as some of the skills will help with the Option papers.



Note you should ensure that you have sat SBR before you attempt AAA.

Useful to attempt SBL before APM.

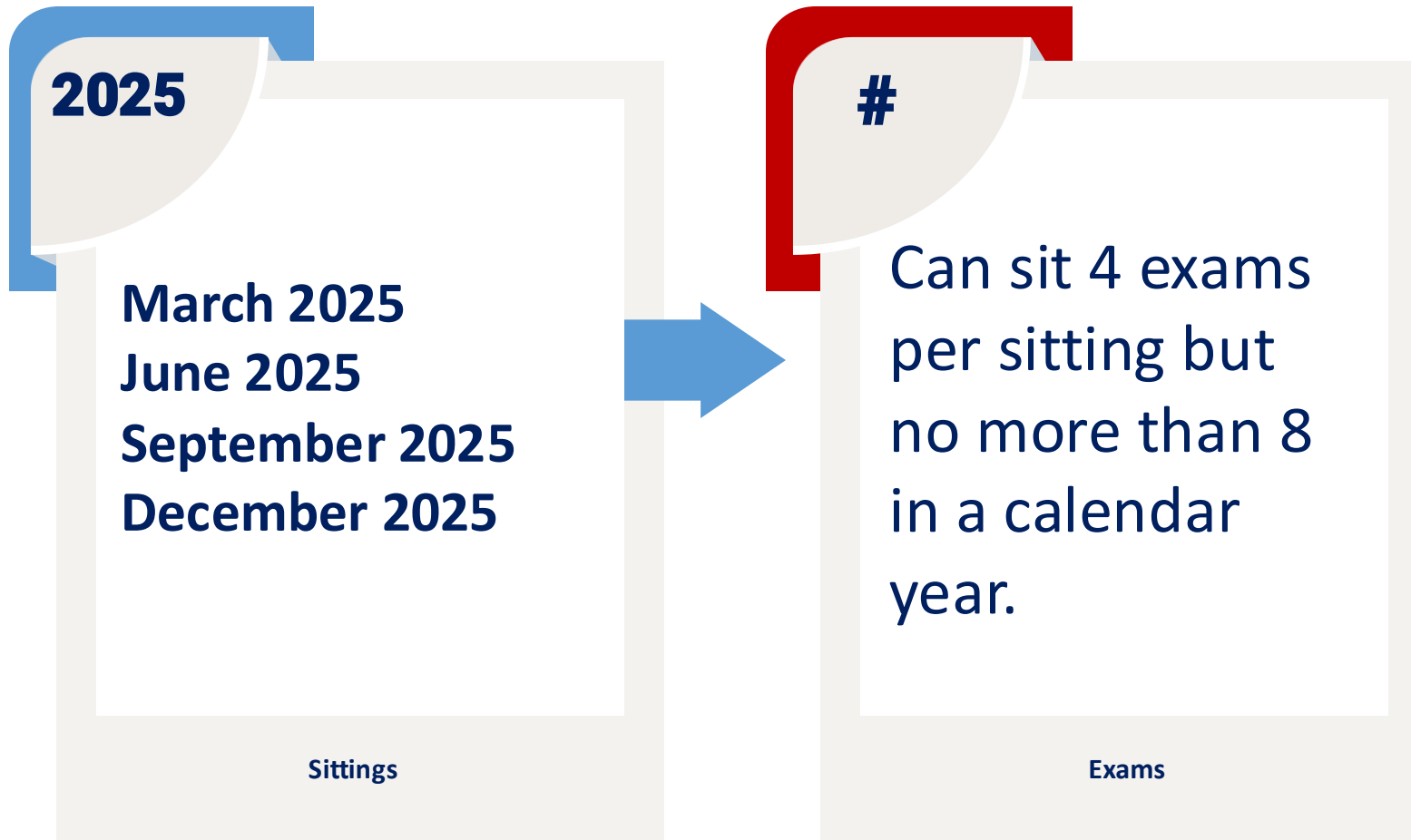

Restrictions

- A number of employers have policies where students will not be given permission to sit exams at specific sittings.
- For example, this may be the March sitting.
- Always ensure that appropriate permission is received before making plans for exams.

4 Sittings Per Annum: You Need a Plan!



'Short Courses' – March & September



- March and September are our 'short' courses.
- Will be intense, generally either
 - 2 evenings per week and a number of weekend dates or
 - 1 evening per week and Saturday or Sunday every week.



- **Issues to consider:**
 - No other major events in your personal or work lives
 - 7 weeks to the exams
 - Very achievable with a high level of commitment.
 - Less work than having 2 subjects at the one exam sitting.
 - Online early start options will be available

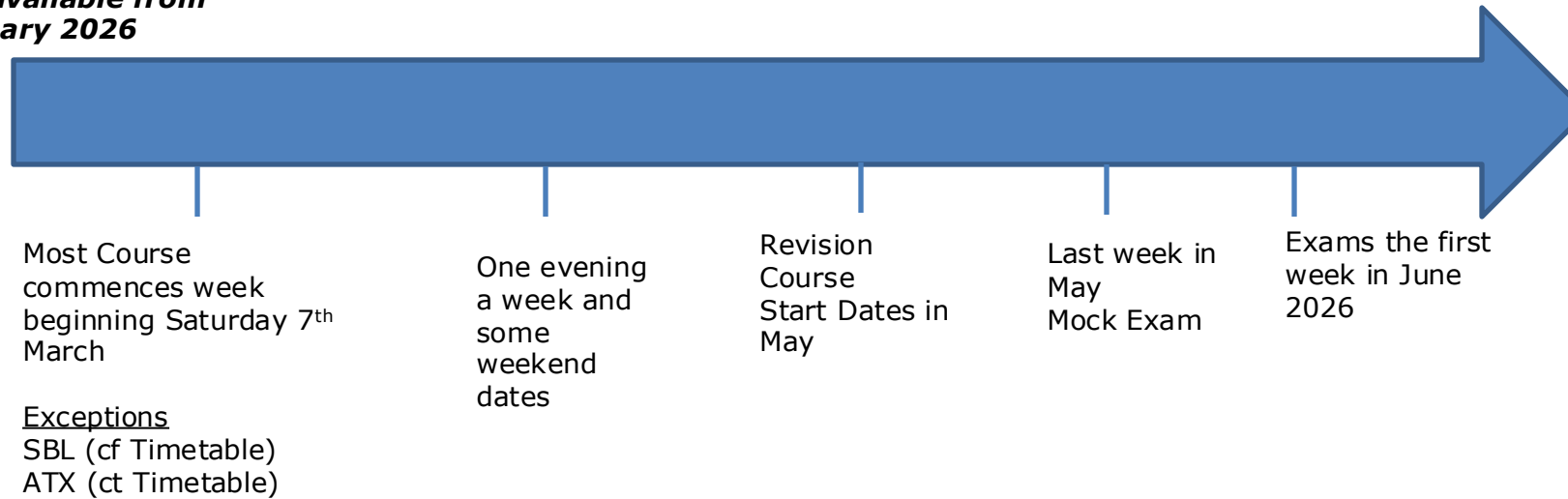
Exceptions

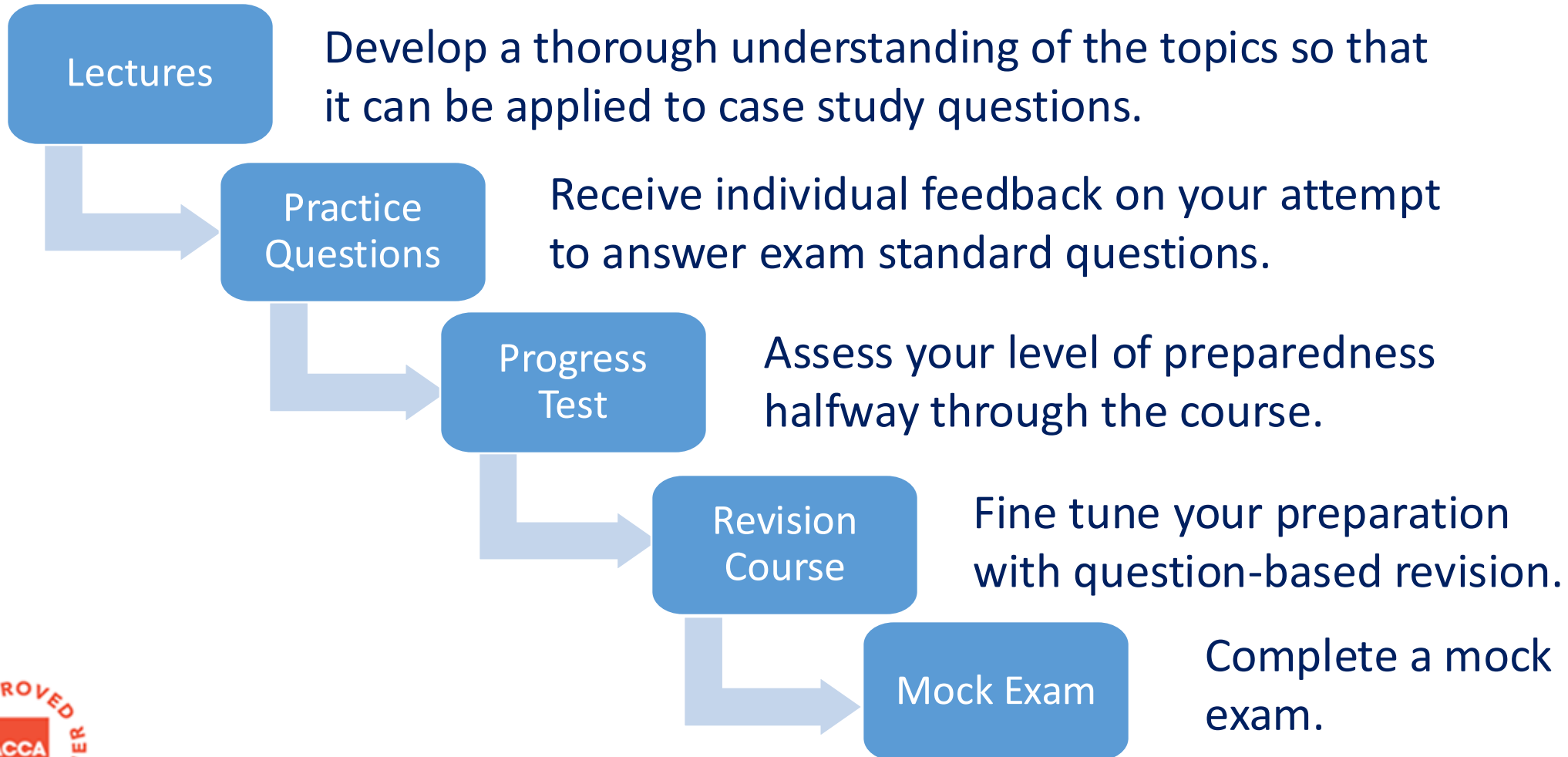

Progression Rules



Progression Rules: Applied Level



The current progression rule is that all Applied Knowledge and Skills papers must be **attempted or being attempted** before a student can commence the Strategic Professional Papers.



There are no time limits for passing the Applied Knowledge and Applied Skills exams (generally) may be some rules to consider at the Applied Knowledge exams.

Progression Rules: Strategic Professional Level

Under the current rules a **seven-year time limit** has been introduced at the Strategic Professional level.



Students will have seven years to pass the exams at SP level.



If a student does not pass all the SP level exams within seven years, they will lose any passes that were achieved more than seven years ago and will need to retake.



The seven-year time limit starts when a student passes his/her first SP level exam.

To take maximum advantage of the support provided by the module, ACCA recommends you complete it **before** attempting any exams at Strategic Professional, but as close as you can to the completion of your Applied Skills examinations.

Practical Experience Record (PER)

- To complete PER you'll need to achieve **36 months of supervised experience** in a relevant accounting or finance role and complete **nine performance objectives** (all five Essentials and four Technical objectives).
- **Many types of experience count** towards your PER. Work completed before registering for the ACCA can also count provided your previous supervisor will sign-off your achievements from that time. – you don't have to achieve 36 months with the same employer
 - Before, during or after you sit your ACCA exams
 - Any industry, sector or country
 - Part-time, temporary or voluntary work
 - Work before registering with ACCA as a student.
 - Internships and volunteering



PER – Approved Employer



- However, if you join an **ACCA approved employer** with training development approval at **Gold or Platinum level** then you can potentially claim performance objective exemption. In that case, you must still complete 36-months of experience before you become an ACCA member.
